Purpose of Development Charges

Development charges provide for the recovery of growthrelated capital expenditures for services related to public works, fire protection, police, indoor and outdoor recreation, library and administration services for engineering and community benefit growth related studies.

The Council of the Township of Cavan Monaghan passed By-law No. 2022-43 on August 2nd, 2022 under the *Development Charges Act*, 1997.



Development Charges are calculated, payable, and collected upon issuance of a building permit for the development. Council may, from time to time, enter into agreements providing for all or any part of a development charge to be paid before or after it would otherwise be payable.

A list of the municipal services for which Development Charges are imposed and the amount of the charge type is provided on the next pages. The schedule of Development Charges will be adjusted annually as of January 1st each year, in accordance with the most recent twelve-month change in the Statistics Canada Quarterly, "Construction Price Statistics".



The information contained herein is intended only as a guide. Applicants should review By-Law No. 2022-43 and consult with the Building Department to determine the applicable charges that may apply to specific development proposals.

Developing in the Township of Cavan Monaghan requires three (3) development charges to be paid:

- 1. Peterborough County
- 2. Educational Charge
- 3. Township of Cavan Monaghan

The current Township of Cavan Monaghan development charges can be found on the back two panels of this brochure.

The charges are flat rate unless otherwise noted.
